Chandana Banerjee, MD, MPA, HMDC, FAAHPM

Chair & Course Director, End of Life Symposium; Director & Designated Institutional Officer, Graduate Medical Education; Assistant Clinical Professor, Supportive Care Medicine; City of Hope

Dr. Banerjee is an assistant clinical professor in the Department of Supportive Care Medicine at City of Hope, where she specialized in palliative and hospice medicine. Her focus is specifically on all educational and clinical aspects related to complex symptom management and end-of-life care. Dr. Banerjee was instrumental in developing City of Hope's

ACGME accredited Hospice & Palliative Medicine Fellowship. She also developed the End of Life Symposium, which was first held at City of Hope in September 2019. The symposium has now been endowed for multiple years. She is the physician lead for Schwartz Rounds at City of Hope and serves as chair on the End of Life Option Act Subcommittee.

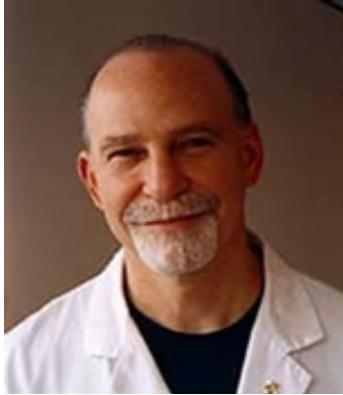
Dr. Banerjee was chair for the American Academy of Hospice & Palliative Medicine's Humanities and Spirituality Special Interest Group from March 2020-2021. She serves on AAHPM's editorial board for the publication AAHPM Quarterly and has served on the assembly's Abstract Review Board for multiple years. She is a reviewer for evidence-based research articles in hospice and palliative medicine submitted to McMaster University in Canada. She currently serves as first vice chair on the board of directors for Compassion & Choices.

Dr. Banerjee's work has been published in newspapers, journals and books. She has spoken at conferences and has been interviewed for her thought leadership in end-of-life care and medical aid in dying. She is the editor for an upcoming book by Springer Publishing's CTAR series exploring views on end-of-life care, death, burial and bereavement within different cultures and religions. Dr. Banerjee is a contributing member on the National Comprehensive Cancer Network Fatigue Panel. Her leadership activities in education include excellence in teaching, faculty development and mentoring, and curriculum and program development.

Dr. Banerjee earned her bachelor's degree in English with an honors scholar designation and magna cum laude from the University of Connecticut. She received her master's degree in public administration from New York University and her medical degree from Saba University School of Medicine. She completed her residency in pediatrics and her fellowship in hospice and palliative medicine from Kaiser Permanente Los Angeles. She is also certified as a hospice medical director.

Dr. Banerjee was recently selected as a Health Equity Scholar into the prestigious Cambridge Health Alliance - Center for Health Equity Education & Advocacy Program's 2021-2022 Cohort.

Dr. Banerjee loves to write poetry and her first collection, "Ashen Leaves," was published in July 2020. Her second book of poems, "Neruda in Bed," is currently in production.



Steven T. Rosen, MD

Provost and Chief Scientific Officer; Director, Comprehensive Cancer Center and Beckman Research Institute; City of Hope

Dr. Rosen is the provost, chief scientific officer, and director of the Comprehensive Cancer Center and the Beckman Research Institute, Irell & Manella Cancer Center Director's Distinguished Chair for the City of Hope in Duarte, California. Following his graduation with distinction from Northwestern University Medical School's Six-Year Honors Program in Chicago, Illinois, Dr Rosen completed his residency in internal medicine at Northwestern and a fellowship in medical oncology at the National Cancer Institute in Maryland. He served as the Director of the Robert H. Lurie Comprehensive Cancer Center at Northwestern University Feinberg School of Medicine from 1989-2014.

Dr Rosen's laboratory research focuses on experimental therapeutics and hematologic malignancies. He has received funding from the National Cancer Institute (NCI), American Cancer Society, Leukemia and Lymphoma Society (LLS), Multiple Myeloma Research Foundation, and Rising Tide Foundation. Dr Rosen has received numerous grant awards and contracts, and has published more than 400 scientific papers. He is editor-in-chief of Cancer Treatment and Research. Dr Rosen is the chair of the Medical Science Committee of the LLS and serves on its Board. He also serves on the Board of American Society of Clinical Oncology's Conquer Cancer Foundation. Dr Rosen has been an advisor to more than two dozen NCI Comprehensive Cancer Centers.

He was the recipient of Northwestern University Medical School's Alumni Achievement Award (1994), the Martin Luther King Humanitarian Award from Northwestern Memorial Hospital (1995), the Marv Samuel Award from the Chicago Baseball Cancer Charities (1996), recognition from the Woman's Board of Northwestern Memorial Hospital for Compassionate Care (1996), and Israel Cancer Research Fund, Man of Distinction Award (2011), and Lifetime Achievement Award (2015). The Giants of Cancer Care award for 2021.



Vijay Trisal, MD

Chief Medical Officer; Norman and Melinda Payson Professor in Medicine; Associate Clinical Professor; Department of Surgery; City of Hope

Dr. Trisal is a highly skilled surgeon who draws raves from patients, as well as a passionate spokesman for the unique brand of compassionate care provided by City of Hope. Dr. Trisal appears regularly on our “Ask the Expert” video series, and he’s a vocal advocate of expanding the City of Hope experience beyond the Duarte campus with community practices

throughout the Southland.

Dr. Trisal says he believes in individualized care, taking into account a person’s family, lifestyle, employment, interests and expectations. He makes a point of spending significant time with each patient he treats. “Time is the most important thing,” he says.

He is a member of the National Comprehensive Cancer Network committee and helps formulate guidelines for the treatment of melanoma both nationally and internationally. Dr. Trisal’s specific interest lies in the study of novel genes that may help in early detection and treatment of melanoma and the use of isolated limb infusion delivering high dose chemotherapy to treat locally recurrent disease.

Educated in India, Dr. Trisal served six years at Providence Hospital and Medical Centers in Southfield, Michigan before arriving at City of Hope in 2002.



Betty Ferrell, PhD, RN

Director and Professor, Division of Nursing Research and Education, City of Hope

Dr. Ferrell has been in nursing for 41 years and has focused her clinical expertise and research in pain management, quality of life, and palliative care. Dr. Ferrell is the Director of Nursing Research & Education and a Professor at the City of Hope Medical Center in Duarte, California. She is a Fellow of the American Academy of Nursing and she has over 450 publications in peer-reviewed journals and texts. She is Principal

Investigator of a Research Project funded by the National Cancer Institute on “Palliative Care for Patients with Solid Tumors on Phase 1 Clinical Trials” and Principal Investigator of the “End-of-Life Nursing Education Consortium (ELNEC)” project. She directs several other funded projects related to palliative care in cancer centers and QOL issues. Dr. Ferrell is Co-Chairperson of the National Consensus Project for Quality Palliative Care. Dr. Ferrell completed a Masters degree in Theology, Ethics and Culture from Claremont Graduate University in 2007. She has authored eleven books including the Oxford Textbook of Palliative Nursing (5th Edition, 2019) published by Oxford University Press. She is co-author of the text, *The Nature of Suffering and the Goals of Nursing* published in 2008 by Oxford University Press and *Making Health Care Whole: Integrating Spirituality into Patient Care* (Templeton Press, 2010). In 2013 Dr. Ferrell was named one of the 30 Visionaries in the field by the American Academy of Hospice and Palliative Medicine.



Christian T. Sinclair, MD

Associate Professor, University of Kansas Health System

Dr. Sinclair is an Associate Professor of Palliative Medicine at the University of Kansas Health System, Editor-in-Chief of the website Pallimed, associate social media editor of the Journal of Pain and Symptom Management, and a past president of the American Academy of Hospice and Palliative Medicine.



Michael Hochman, MD, MPH

Chief Executive Officer, SCAN Medical Group (Homelessness Initiative)

Dr. Hochman is the inaugural CEO of SCAN's Homeless Medical Group initiative. Under his leadership, the group uses a "street medicine" model to focus on the care of patients experiencing homelessness in California. Dr. Hochman, a board-certified general internist, is an active physician providing care within the medical group.

Dr. Hochman previously served as the inaugural director of the USC Gehr Family Center for Health Systems Science and Innovation; the Medical Director for

Innovation at AltaMed Health Services; and the Senior Health Deputy for LA County Board of Supervisor Member Mark Ridley-Thomas.

Dr. Hochman attended Harvard Medical School. He completed his residency in Internal Medicine at the Cambridge Health Alliance and was a Robert Wood Johnson Foundation Clinical Scholars Fellow at UCLA. As an instructor, Dr. Hochman has won several clinical teaching awards from Harvard Medical School and LAC+USC Medical Center.

Dr. Hochman has written on health topics for the Boston Globe and other publications, and is the founding editor of the [50 Studies Every Doctor Should Know](#) book series published by Oxford University Press.



Alan Elbaum, MS

University of California Berkeley - University of California San Francisco Joint Medical Program

Alan Elbaum is a 4th-year medical student at UC San Francisco, going into psychiatry and interested in the intersection between mental health and end-of-life care. Prior to medical school, he worked as a disability rights advocate at a Palestinian organization in Nazareth, Israel. During the course of his medical training, he completed one summer of clinical pastoral education (hospital chaplaincy training). He is the author or coauthor of several articles and book

chapters examining the ethical implications of racial health care disparities and divergent cultural values as they relate to decision-making at the end of life.



Stephen J. Forman, MD

Professor, Department of Hematology and Hematopoietic Cell Transplantation; Director, Hematologic Malignancies Research; Institute Director, T Cell Therapeutics Research Laboratories; Professor, Department of Medical Oncology and Therapeutics Research; City of Hope

Dr. Forman is an international expert in hematologic malignancy, cancer immunotherapy, and bone marrow transplantation. He is the Director of the Hematologic Malignancies Research Institute, Director of the T Cell Therapeutics Research Laboratories as well as staff physician in both the Department of Hematology and Hematopoietic Cell Transplantation and Department of Medical Oncology and Therapeutics Research at the City of Hope Comprehensive Cancer Center. Dr. Forman is also co-editor of "Thomas' Hematopoietic Cell Transplantation," the definitive textbook for clinicians, scientists and health care professionals. In addition, for his work he has been awarded the DKMS Mechtild Harf Science Award and the E. Donnall Thomas Lectureship.

In nearly 40 years at City of Hope, Dr. Forman has lead laboratory and clinical research that has advanced our understanding and treatment of patients with cancer. His current laboratory and clinical research is focused on CAR T cell cancer immunotherapy to treat both hematologic and solid tumor cancers.



Yelena Zatulovsky, LCAT, LPMT, MA, MT-BC, CCLS, HPMT

Vice President of Patient Experience, Seasons Healthcare Management - Seasons Hospice & Palliative Care

Yelena Zatulovsky is the Vice President of Patient Experience at Seasons Hospice & Palliative Care with over 20 years of bedside experience working with patients and families at the end-of-life. In addition to hospice and palliative care, Yelena is licensed as a Mental Health Practitioner, board-certified as a Child Life Specialist, and holds an advanced designation (along with board certification) as a Hospice & Palliative Care Music Therapist. Along with Yelena's clinical work, Yelena currently serves on NHPCO's Ethics Advisory Council and on C&C's Healthcare Advisory Council. She previously served on NHPCO's Pediatric Advisory Council, served on the Children's Advisory Board of HPCANYS, contributed a training module to the HIPPC (HPCANYS Initiative for Pediatric Palliative Care) curriculum, has multiple published articles and chapters, and has presented at multiple conferences nationwide. In 2011, Yelena's music therapy work, along with that of several colleagues, was featured in the New York Times and in 2014 Yelena was honored as one of Jewish Week's 36 Under 36. Yelena is concurrently pursuing her Doctoral Degree in Clinical Bioethics.



Glen I. Komatsu, MD

Regional Chief Medical Officer, Providence TrinityCare Hospice Care

Dr. Komatsu earned a BS in biological sciences at the University of Arizona and his MD at the Arizona College of Medicine. After completing a pediatric residence at UC Irvine Affiliated Hospitals and a neonatology fellowship at Long Beach Memorial/Miller Children's Hospital, he entered private practice. He served as medical director of the Neonatal Intensive Care Unit at Providence Little Company of Mary Medical Center, Torrance from 1985-2004, as well as director of bioethics for Providence Health & Services in the South Bay. In 2004, Dr. Komatsu pursued an additional specialty by taking an adult palliative care fellowship at Dana-Farber Cancer Institute, Brigham and Women's Hospital, and Harvard Medical School. Returning to California in 2005, he now serves as Chief Medical Officer for Providence TrinityCare Hospice and Regional Palliative Care Southern California, Medical Director for TrinityKids pediatric hospice, director of the Edmond R. and Virginia G. Doak Center for Palliative Care at Providence Little Company of Mary Medical Center, Torrance and Medical Director of Palliative Care at Children's Hospital of Orange County.



Susan Elizabeth Wang, MD, HMDC

Chief, Geriatrics & Palliative Medicine; Medical Director, Life Care Planning & Serious Illness Care; Southern California Permanente Medical Group; Kaiser Permanente

Dr. Wang is the national lead for Dignified Journeys and Palliative Care at Kaiser Permanente (KP), where she supports the implementation of a high-quality ecosystem for the care of people with serious illness. Dr. Wang is also regional chief of the Department of Geriatrics & Palliative Medicine in KP Southern California. In this role, she oversees home-based palliative care, palliative clinic, geriatric clinic, inpatient palliative service and a robust SNF rounding program in 16 hospitals. She is the regional hospice medical director for an agency with an average daily census of 800 patients. She has led KP SCAL as Medical Director of Life Care Planning and Shared Decision Making for over a decade, creating a centralized advance care planning tab, an E-POLST, a primary palliative-skills curriculum, and multiple tools to enhance decision support for patients and families.

Dr. Wang is Director Emeritus of the KP LA Hospice & Palliative Medicine fellowship, a program she created in 2008. She is an assistant clinical professor at UCLA and triple board-certified in Internal, Geriatric and Palliative Medicine. She represents KP on the National Academy of Sciences Roundtable on Quality Care in Serious Illness. She served on the National Quality Forum to establish Standards for Certification of Decision Aids. Dr. Wang has multiple publications with a focus on community palliative care and treatment concordance.



Purvi Patel, MD, MBA

Hospice & Palliative Medicine; SBC Kaiser Permanente

Dr. Patel attended the University of California, Irvine where she received her Bachelor of Science in Biological sciences and her Bachelor of Arts in Psychology. She later attended the American University of Antigua College of Medicine where she received her Medical Degree and completed a simultaneously Masters Program with Plymouth State University for her Master's in Business, with a focus on Healthcare Administration. Dr. Patel went on to complete residency in Family

Medicine at Hofstra University, North Shore Long Island Jewish (now Northwell Health) where she served as chief resident. She completed fellowship in Hospice and Palliative Medicine at Memorial Sloan Kettering Cancer Center and has worked as an attending physician in Hospice and Palliative Medicine since. She has authored and co-authored several works regarding cancer pain management, palliative symptom management and end of life care.



Sorin Buga, MD, FACP, FAAHPM

Clinical Professor; Program Director, Hospice and Palliative Medicine Fellowship; City of Hope

Dr. Buga is a Clinical Professor in the Department of Supportive Care Medicine at City of Hope, Duarte, California where he serves as the Program Director for the fellowship in Hospice and Palliative Medicine. He is board certified in hospice and palliative medicine and a fellow of the American College of Physicians and of the American Academy of Hospice and Palliative Medicine. He completed his fellowship in palliative medicine at H. Lee Moffitt Cancer Center in Tampa, Florida. He

is the City of Hope's representative on the NCCN Adult Cancer Pain Panel and an active member of the American Academy of Hospice and Palliative Medicine, the International Association for Hospice and Palliative Care and International Association for the Study of Pain. He has published in the peer review literature and is often invited to speak at scientific meetings.



Azra Raza, MD

Chan Soon-Shiong Professor of Medicine; Director, Myelodysplastic Syndrome (MDS) Center; Columbia University Medical Center

Dr. Raza is a Professor of Medicine and Director of the MDS Center at Columbia University in New York, NY. She started her research in Myelodysplastic Syndromes (MDS) in 1982 and moved to Rush University, Chicago, Illinois in 1992, where she was the Charles Arthur Weaver Professor in Oncology and Director, Division of Myeloid Diseases. The MDS Program, along with a Tissue Repository containing more than 50,000 samples from MDS and acute leukemia patients was successfully relocated to the University of Massachusetts in 2004 and to Columbia University in 2010.

Before moving to New York, Dr. Raza was the Chief of Hematology Oncology and the Gladys Smith Martin Professor of Oncology at the University of Massachusetts in Worcester. She has published the results of her laboratory research and clinical trials in prestigious, peer reviewed journals such as The New England Journal of Medicine, Nature, Blood, Cancer, Cancer Research, British Journal of Hematology, Leukemia, and Leukemia Research. Dr. Raza serves on numerous national and international panels as a reviewer, consultant and advisor and is the recipient of a number of awards.



Blanca Rivas, LCSW, ACHP-SW, CSW-G

Social Work Program Specialist – End of Life Option Act, City of Hope

Blanca Rivas has been a clinical social worker in the Department of Supportive Care Medicine at City of Hope for 12 years. She received her undergraduate degree in Psychology at U.C. Berkeley, and a Master of Social Work at Tulane University in New Orleans. Her clinical expertise has focused on breast cancer, urologic cancers, and medical aid-in-dying. She became a co-leader for the End of Life Option Act program at City of Hope in 2016. In this role, she provides education, support, and guidance when patients choose to explore and request medical aid-in-dying. Prior to City of Hope, she worked extensively with populations affected by HIV, mental illness, and homelessness in San Francisco, as well as in New Orleans, post-Hurricane Katrina.



Victoria Ramirez, LCSW, ACHP-SW

Social Work Program Specialist – End of Life Option Act, City of Hope

Victoria Ramirez has been at City of Hope for 7 years as a Licensed Clinical Social Worker. She co-leads the End of Life Option Act program and is the clinical social worker for the brain tumor program. She earned her undergraduate degree at Cal Poly Pomona in Sociology/Criminology and her Master of Social Work degree at the University of Southern California. Her passion is helping to honor patients' dignity, values, and wishes while navigating them through End of Life.



Kimberly Shapiro, MD

Medical Director, Outpatient Behavioral Health and Wellness; Mission Hospital Laguna Beach

President & Chief Executive Officer, Compassion & Choices

Kim Callinan has served on the Compassion & Choices leadership team for nearly six years, first as Chief Program Officer and now as the organization's President & Chief Executive Officer. During her combined tenure at Compassion & Choices, Kim has played a leadership role in authorizing and implementing medical aid in dying into six new jurisdictions, including the recent passage of New Mexico's End of Life Options Act. She was instrumental in drafting Compassion & Choices' current five-year strategic plan, implemented in 2018. She also launched our Finish Strong initiative, which includes a book and a suite of new tools designed to empower patients to take charge of the final chapter of their lives, including focused efforts on helping people plan for a possible dementia diagnosis and closing the disparities in end of life care and planning that exist for communities of color.

Kim frequently speaks at conferences, testifies before state legislatures, conducts policy briefings and serves on committees as a subject-matter expert on end-of-life care options. Prior to joining Compassion & Choices, Kim spent two decades creating integrated campaigns to engineer social change, including supporting issue campaigns to reduce the number of uninsured Americans and improve children's health, and political campaigns at the federal, state and local levels.

PATIENT CARE

Physicians must be able to provide patient care that is compassionate, appropriate, and effective for the treatment of health problems and the promotion of health. **CME programs address these issues if they address topics related to:**

- The ability to communicate effectively and demonstrate caring and respectful behaviors when interacting with patients and their families;
- gathering essential and accurate information about their patients
